The **Association of Kentucky Fried Chicken Franchisee Political Action Committee (“AKFCF PAC”)** is only permitted to solicit contributions from the AKFCF members. However, because your franchise is the AKFCF member and it is an incorporated entity, the attached “Prior Authorization” form is **required by law** to be reviewed, signed on each line and returned before any letter of solicitation can be issued to you via e-mail or post on behalf of the AKFCF PAC. The attached form provides the specific language required under the Federal election law. **Your timely attention to this letter is very important.**

The importance of your compliance and support is critical to the success of the AKFCF PAC.

Our PAC was developed to fully utilize AKFCF’s Governmental Affairs team as well as strengthen AKFCF’s presence in D.C. We have made great progress in a short amount of time, but we need your help to continue this effort. We must maintain bipartisan pro-business/pro-franchisee majorities in both Houses of Congress and are requesting that you consider making a voluntary contribution to the AKFCF PAC.

The suggested minimum contribution is \$100 per member per store. Each franchisee may legally contribute up to \$5,000 to the PAC per calendar year. Please consider what each of us spends annually on equipment, advertising, labor and signage. Considering \$100 per member per store is only 0.01% for a store with \$1 million annual expenses, we believe that a \$100 per member store is a small investment given what’s at stake. Now more than ever it is imperative that AKFCF franchisees step up to the plate.
